GENERAL INFORMATION ABOUT THE MA PROGRAM IN CULTURAL HERITAGE STUDIES

Within the Institute of History, the Department for Interdisciplinary History has been providing education in the field of cultural heritage since 2012, initially as a specialization of the History MA program, and from 2016 in the form of an independent Hungarian master's degree program. Since 2018, the Department has been coordinating a bilingual (English and French) Erasmus Mundus Joint Master Degree program on cultural heritage (TEMA+ European Territories. Heritage and Development), in association with four partner universities (Charles University, Prague; École des Hautes Études en Sciences Sociales, Paris; University of Catania; Université Laval, Québec) and in cooperation with European Heritage Label (EHL) and various UNESCO organs. The English-language Cultural Heritage Studies MA program is based on the domestic and international experiences of the department. The program includes two specializations: 1) Theory of Cultural Heritage, 2) Museum and Curatorial Studies. The program provides internships for students in several institutions involved in heritage protection and management. By combining theoretical and practical knowledge, the MA program prepares students for academic careers as researchers and/or for working opportunities in various branches in the field of cultural heritage.

FOREIGN LANGUAGE REQUIREMENTS

Non-native speakers of English must demonstrate a sufficient level of English-language skills. The Test of English as a Foreign Language (TOEFL) exam [the minimum recommended score is 550 on the paper-based exam (PBT) or 80 on the Internet-based exam (iBT)] and the IELTS exams (with a recommended score of 6, and above) are preferred.

REQUIREMENTS FOR APPLICANTS

Applicants must hold a university bachelor's (BA) degree (or an equivalent college degree) in the fields listed below.

Previously earned credits are acknowledged for entry into the program *in full* if the applicant holds a BA degree in *social science* bachelor's degree programs, or *humanities* bachelor's degree programs as follows: *liberal arts, history, archaeology, ethnography, and Hungarian.*

Applicants with a BA degree in architecture and architectural design must have at least 30 credits to enter the program, from areas related to cultural history (cultural anthropology, ethnography, archaeology, philology, aesthetics, art history, history, and cultural studies). Applicants holding diplomas from any other bachelor and master's degree programs, as well as programs corresponding to Act LXXX of 1993 on Higher Education accepted by the Credit Transfer Committee of the Faculty of Humanities of ELTE, on the basis of a comparison of the knowledge on which the credit is based, must have at least 40 credits from areas related to cultural history (cultural anthropology, ethnography, archaeology, philology, aesthetics, art history, history, and cultural studies); they can be admitted with a minimum of 30 credits to the program, while the remaining credits should be earned during their first two semesters at the Cultural Heritage Studies MA program in conformity with the Studies and Exams Code of the Faculty of Humanities of ELTE.

DOCUMENTS TO BE SUBMITTED BY THE APPLICANT:

- Cover letter indicating why the applicant wishes to start the program, and what his/her special field of interest is.
- Curriculum Vitae including the applicant's previous achievements (scholarships, publications, conference presentations, cultural projects, business experience, voluntary work, etc.)
- English-language transcript with the list of completed courses in previous degree programs.
- A preliminary research proposal for a proposed thesis project with a study and research plan (detailed outline of your field of interest), a preliminary bibliography (indicating what the applicant has read already).

MA THESIS AND FINAL EXAMINATION REQUIREMENTS

The thesis is a piece of independent scientific work of the candidate, the topic of which is determined by the thesis supervisor and the candidate from the field of study taught at the Department. It displays the knowledge of the candidate acquired in the MA Program, the familiarity of the candidate with the literature of the given scientific and/or professional questions, and his/her analytic skills. All students are required to choose a supervisor and consult with

them at least three times; failing this, the supervisor may propose the rejection of the thesis. All cases where a student's work is suspected of plagiarism will be brought to the Board of Review of the Faculty of Humanities.

FORMAL REQUIREMENTS

Length: minimum 200.000 characters (with spaces and notes but not including the cover page, table of contents, bibliography) at 1.5 spacing and 12 pt font in Times New Roman.

The MA thesis (with its attachments) is to be submitted (uploaded) electronically in PDF or WORD format as *a single file* into the University's electronic admin system (Neptun).

The title page of the thesis must include the name of the author; the title of the MA thesis in Hungarian, as well as in the language of the degree program; the name of the university, the faculty and the name of the program; the name of the thesis supervisor; and the year of submission of the thesis.

The thesis must be accompanied by a written statement from the student that the work is his/her own intellectual product. The thesis cannot be submitted without the written approval of the supervisor.

ASSESSMENT

The thesis is assessed by two reviewers, who cannot be identical to the supervisors of the thesis. The two reviewers' assessment results mark of the thesis which is determined by the final examination committee at the final examination. If one of the assessments is insufficient (a 'fail'), the thesis will be rejected.

Assessment happens on a five-grade scale. During the evaluation, the referee must take into account whether the author has adhered to the prescribed requirements concerning content and form. The factors relevant for grading are:

- standard literature references with a Bibliography
- a text in English divided into chapters with a table of contents and conclusion (theme choice, research question, method, discussion, result)
- 10-line abstract
- statement about the originality of the submitted work

CONTENT REQUIREMENTS

- relevant topic in cultural heritage studies
- the topic discussion is based on relevant international literature in English
- the discussion is based on original research
- appropriate academic language (in English)

PREREQUISITES FOR THE FINAL EXAMINATION

The prerequisites for the final examination are:

- completion of the study unit list and exams specified in the curriculum for the programme (with the exception of the thesis, and the final examination)
- fulfilment of all training and completion requirements
- a certificate stating that the student has returned all property borrowed from the university.

REQUIREMENTS FOR THE MA FINAL EXAMINATION

The final examinations are conducted orally, based on the topic(s) of the final examination (as set by Atelier Department).

EVALUATION AND GRADING OF THE FINAL EXAMINATION

Assessment is on a five-grade scale, based on (i) the *defence* of the thesis and (ii) the *topic*(s) of the final examination.

The examiners evaluate the answers of the examinee in scientific/professional areas related to the evaluation of the MA thesis, and also assess the professional background of the examinee along with his/her ability to carry out scientific/professional discourse based on the submitted bibliography of the thesis.

DEGREE CERTIFICATE

The degree certificate states the mathematical average (rounded to the closest whole number) of (i) the grade of the *thesis* and (ii) the *grades received at the final examination*.

The grade of the final examination is calculated on the basis of the defence of the thesis and the grade obtained for the topic(s) of the final examination (as set by Atelier Department).

According to Section 84 (6) of Academic Regulations, (HKR) the degree (diploma) is classified (graded) according to its average down to two decimals:

- outstanding (5), if the average is 5.00
- excellent (5), if the average is 4.51–4.99
- good (4), if the average is 3.51–4.50
- satisfactory (3), if the average is 2.51–3.50
- pass (2), if the average is 2.00–2.50.
